According to the Consumer Product Safety Commission, 200,000 children are treated annually for playground accidents. Of these, 70%, or 140,000 occurred at public parks and schoolyards. Sponsored by the National Recreation and Playground Association and Ohio Parks and Recreation Association, this CPSI course is the most comprehensive training program on playground hazard identification and risk management methods offered. Advanced reading and 12 hours of training will prepare you for the Certified Playground Safety Inspector Exam scheduled at the culmination of this certification course.

Continuing Education Units

Earn 1.5 CEUs while participating in this seminar. Be sure to sign the attendance roster for our records before leaving the seminar.

Certification

Those taking the course are eligible to take the CPSI Certification Exam given immediately after the course. Upon successfully passing the exam, you will be certified through the National Recreation and Park Association as a Certified Playground Safety inspector (CPSI) for a three year period. Certificates will be awarded and your name will be added to the national roster of CPSIs. Starting July 1, 2026, those who are currently certified may renew their certification by acquiring 2.0 CEUs.

Exam Requirements

Candidates sitting for the CPSI Certification examination must be 18 or older and have a high school degree or equivalent.
